He kaiwaiata ia i ngā kōnehete me ngā Whakataetae o Ngāti Poneke, ā, i tū ia i te taha o Vicki Ward rāua ko Tairora hei Kaikaranga mō te Karapu, me te Marae o Pipitea.



He mema mamahi ia nō te Rōpū o Ngāti Poneke, arā te Ngāti Poneke Māori Association me te Marae Charitable Trust. He Pōkai Kura ia nō te Kārapu e kīa nei ko Ngāti Poneke Young Māori Club me te Ngāti Poneke Māori Association.

I te Rārangi Tohu Hōnora a te Kuīni mō te Tau 2007 ka whiwhi a Puti i te Merara a te Kūini mō te Āwhina i te Iwi (QSM) mō ana āwhina i ngā toi ataata Māori, me ana mahi mō ngāi Māori. He ngāhaku mahaki, otirā, nā tana kite he nui ngā kaupapa e tika ana kia hāpainga kāore he mutunga o ana mahi i te ao i te pō mō te rangatahi, me te hanga pakeke.

I tū ia hei kanohi mō te Wellington Māori Cultural Society. I noho hoki ia hei Kaitiaki Moni mō te rōpū, ā, he toa ia mō te1 āwhina i te whakamahere me te whakahaere o ngā Whakataetae Kapa Haka ā-Rohe o Te Whanganui-a-Tara. Tēnā tātau Te Matatini,  
otirā te hunga manaaki i te ao kapahaka, ōna reo me ōna tikanga  
“Mana Motuhake ki te kāinga matatū mataora Matatini ki te ao”  
Haruru ana hoki te hinganga o ngā kaihautu o taku waka auahi ana taku raru e.  
Koutou te iti te rahi te whakamataku hoatu haere ki ngā matangireia o te pō takoto i te āio o  
te rangi.  
E hika mā ka mutu pea te tau ko tēnei mō ngā āhuatanga i hua mai hei waha i te Matatini e  
haere ake nei.  
Kauria mai ki roto i te ripoata nei hei reira kite ai i te pē o ngā ringa, i te pono o ngā whakaaro  
mō ā tātau whare Karioi o te motu.

I a au e huritao nei mō ngā wero mutunga mai o te mea hou i waipuke mai ki runga o  
Aotearoa i muri i te pānga tuatahi mai o COVID-19 i ngā wiki whakamutunga o Pēpuere 2020,  
ka mōhiotia nā te mahi kamakama o te motu katoa i ora ai te tini o te tangata. He tere tonu  
ngā whakatau kia katia ngā taupā o tō tātou whenua, ā, i whakamania ētahi kati tino mārō,  
me te aha, ahakoa ngā mānukanuka, i tauri tātou ki te pānga tērā pea ka hua ake mō te  
ahurei ā-rua tau kua oti te whakarite ōna rā mō Te Matatini i 2021, kia tū ki Ngā Ana Wai -  
Eden Park i Tāmaki Makaurau.

I noho ko tō tātou ū mutunga kore ki te kaupapa e mōhiotia nei ko Tiakina tō Whakapapa,  
me te hauora, te toiora hoki o tō tātou whānau, hei whakaaro tiketike rawa i roto i aua wā  
o te rangirua mō te tini. I ū tātou ki ngā whakahau me ngā aratohu nā Te Manatū Hauora  
me te Kāwanatanga o Aotearoa i whakahau, ā, i tika ana tā mātou whakaterere i waenga  
i ngā mōreareatanga, i runga anō i ngā whakatau i whakaetia e tō tātou whānau. Nō te  
tauwharenga mai o ēnei ngaru i torotoro mātou i ngā kanohi o ngā rohe, i tāraia he tikanga  
tūpono, me te aha, i whakakāhoretia e tātou te ahurei taea noatia te Pēpuere 2023, kia tū  
tonu i Nga Ana Wai - Eden Park i Tamaki Makaurau.

He tino kōhikohiko ngā mahi o ēnei tau o waenga mō ngā tira Kapa Haka whakakitekite.  
He tino nui ngā taumahatanga o te haere ki ngā whakaharatau, ki ngā whakatūtū waewae,  
ahakoa kua herea ngā mema tira ki tō rātou takiwā motuhake i Aotearoa, kāore i taea te  
haere ki aua whakaharatau. E tika ana kia mihia rātou mō rātou i whakamanawanui mō te  
kaupapa, kia tū rangatira i mua i te ao ki te whakakite i ēnei toi o ngā tīpuna, ahakoa ngā  
pīkauranga me ngā raruraru o te wā.

Nō mua tata atu i te whakatuwheratanga o Te Matatini Herenga Waka Herenga Tangata,  
i pā ētahi tukinga marangai nunui e rua ki Aotearoa. Ko te tuatahi i pā i te marama o Hānuere,  
i te waipuketanga o Tāmaki Makaurau e Huripari Gabrielle, me te karawhiunga o ngā rohe  
o Kahungunu, o Te Tairāwhiti me Te Taitokerau. I roto i ngā rā o muri mai, i kimi tohutohu  
mātou mai i ngā rohe i tino pāngia, ā, he marama te whakautu, me haere tonu te Ahurei.  
I tautoko a Te Matatini i ngā tira tū ki te atamira i tino pāngia, kia tae pai mai ai rātou ki te ahurei.

Ko te tutukitanga o ēnei mahi ko te puāwaitanga o ngā mahi ātaahua o Te Matatini Herenga  
Waka Herenga Tangata, i kitea, i noho hoki hei mea ngahau mā te hia miriona tāngata i  
Aotearoa, huri noa hoki i te ao.

I muri mai i tēnei ekenga taumata hira, ka pā mai te rongo kua tohaina mai tētahi tahua  
\$34 miriona i roto i te whakapuaki Rārangi Pūtea 2023. Kātahi tonu nei a Te Matatini ka  
whakanui i tōna huritau 50 o ngā mahi Kapa Haka i te tau 2022, ā, i noho tēnei whakaohonga  
pūtea mō ngā tau e rua hei whakapiki i ngā hua papai o Kapa Haka ki tō tātou hapori o  
Aotearoa hei tohu nui. Nā konei ka pakari kē atu te whakawhanake i ngā mahi Kapa Haka  
hei wāhi ahurei, tōtahi hoki o tō tātou tuakiri hei whenua motuhake.

Ka riro mā Te Pitau Whakarei e arataki tā tātou mahi i roto i te wāhanga whakawhanake  
whai ake, ko te whakawhanaketanga Kapa Haka tērā, ko te poipoi i ngā taiohi whai pūmanawa  
tērā, ko te whakatena pihinga pakihī, tērā, ko te tiaki i ngā rawa ā-hinengaro o tō tātou kapa  
tērā, me te whakapiki i te māramatanga ki ngā mahi papai o te ao Kapa Haka mō tō tātou  
whenua katoa.

Ko tō tātou whāinga matua ināianei he whakatū i ngā tūāhanga e tika ana hei tautoko i ngā  
tupunga kua oti te whakamahere, me te tohanga tōkeke i te 70% ōrau o ngā pūtea i roto i  
te \$34 miriona i whakawhiwhia mai rā i te Rārangi Pūtea 2023 ki ngā rohe hei te marama o  
Hānuere 2024.

I a tātou i hanatu rā ki tēnei hīkoi hou, kia whiwhi pūtea tōtika mō Te Matatini, kei te tuku  
atu au i aku whakamoemiti ki a koutou katoa i whai wāhi mai, ahakoa nui, ahakoa iti, kia tae  
tātou ki tēnei wā. E tū tahi ana tātou ki te kawē whakarunga i te kaupapa mau tonu o te Kapa  
Haka, me te tuitui i tōna ihi ki roto i te manawa pū o te ao ahurea o tō tātou whenua.

## Mai i te Manahautū

I te timatatanga te kupu. Ko te kupu Te Atua. Ko te Atua anō te kupu o te timatatanga, nāna ngā mea katoa i hanga. Horekau i tētahi mea, kāhore te hanga i a ia. Ko ia te ora, ko te ora te māramatanga mo ngā tāngata katoa. Nō reira, he hōnore he korōria ki te Atua e koropiko ana tātou ki a ia. Huri noa ki te hunga Kapa Haka, mai i Te Hiku o te ika, Te Puku o te Whenua, Te Ūrunga mai o te Rā, Te Ūpoko o te ika, tae rawa hoki ki Te Waka a Māui. Tena koutou katoa

### Tirohanga Whānui

Ka eke tēnei ki te tau tuawhito o Te Matatini e hora nei i ngā whakaritenga o Te Pītau Whakareī – tō mātou rautaki 10-tau hei arataki i te whakahaere kia pai ai tāna whakatutuki whai hua i ngā hiahia me ngā wawata o ngā rohe. Kua tae tātou ki tētahi pekanga hira i te ara, i a mātou e mahi nui nei ki te whakawhānui i te hōkai whakarato a Te Matatini ki te tautoko, ki te whakamana hoki i ngā Kapa Haka i ō tātou hapori.

Kua aro nui Te Matatini ki te whakapūmāutanga o te hua o Te Kapa Haka mō Aotearoa ki tua rawa o te atamira, me te whakarite ara e tika ai te whāngainga pūtea tōitū, ōrite hoki mā Te Matatini. E kawē kē ana mātou i te whakahaere i ōna āhua o mua, he hora i te ahurei ā-rua tau ā-motu anake te mahi, kia tū hei rōpū mahi nui, whakatairanga hoki i ngā painga o te Kapa Haka mō Aotearoa.

### Ko te Ahurei o Te Matatini Herenga Waka Herenga Tangata National Kapa Haka 2023

I whakatūria Te Matatini Herenga Waka Herenga Tangata i Tāmaki Makaurau mai i Huitanguru 21-25 2023, kātahi te hui ātaahua! Ko Te Matatini o tēnei tau te ahurei nui rawa, te ahurei pai rawa mai o tōna tīmatanga i 1972. Ki ngā tatauranga, i tahuri te tini o ngā minenga o Aotearoa me Ahitereiria ki te mātaki ki ngā mahi Kapa Haka; he torowhānui āna pāhotanga; ā, he nui ngā kupu whakamihi mai ki ōna painga.

I mātaki ngā minenga nui atu i te 70,000 i roto i ngā rā e whā, ā, i mātaki tuihono mai ētahi tangata 730,000 nō Aotearoa ki te pāhotanga mataora i TV2, 1.8 miriona i mātaki ki te ahurei i TVNZ+, kāti, i tahuri mai ētahi kaiwhakarongo 35,000 ia rā ki te whakarongo ki te ratonga whakapākehā kupu.

I ā mātou tūāpapa pāpori o Te Matatini, i piki te tuinga mai o te hunga i Facebook mā te 400+%, waihoki i Instagram i piki te hunga whakapiri mai mā te 860% i roto i ngā rā e whā. Kua piki te whakapiringa mai mā te Tik Tok mā te 9000+%, i tōna tīmatanga 1000 noa iho te hunga whai mai, i piki ki te 100,000 ngā hoa piri mai i te taenga ki te rā tuawhā.

E ai ki te pūrongo pānga whai mana mō Te Matatini Herenga Waka Herenga Tangata i eke te whakataunga harikoa minenga toharite ki tētahi taumata tiketike rawa, e 8.8 (i tētahi inenga mai i 1 ki te 10). I eke te taumata o te hunga i kī ka hoki mai anō ā ngā tau kei mua i te aroaro, ki te iwa tekau mā rima ōrau. Kua whakaatatia ēnei whakaaro i roto i te Tapeke Kaiwhakatairanga More ki tētahi taumata tiketike, he +85.

E ai ki ngā matapae ko te takoha ōhanga o Te Matatini Herenga Waka Herenga Tangata ki Tāmaki Makaurau tata ki te \$22 miriona te rahi. Ko te takoha tiketike rawa tēnei o ngā hui katoa o Te Matatini i aromātaingia mai i 2011, he tino nui te hipanga ake. Hāunga tana pānga ōhanga, e ai ki ngā urupare mai i te hunga i tae ake me te hunga pupuru pānga, he whānui kē atu ngā pānga pāpori, toiora, ahurea hoki o Te Matatini Herenga Waka Herenga Tangata.

### He pūtea nui kē atu hei tautoko i te tupuranga ā-rohe o ngā mahi Kapa Haka

I te marama o Haratua 2023, nā te Kāwanatanga i whakapuaki ka whiwhi Te Matatini i tētahi \$34 miriona tāpiri hei wāhi o te Pūtea ā-Motu 2023, i roto i te rua tau hei whakatinana i tā mātou matakite, arā, Mana Motuhake ki te kāinga: Matatū, Mataora, Matatini ki te ao – mā te rohe e arataki, mā Te Matatini e whakamana. Mā tēnei mātou hei kawē ki tua o te ahurei ā-rua tau o Te Matatini, e hua ake ai ngā pūtea toitū hei whakatūturu i tā mātou tauira i takea mai ngā rohe, me te rironga tika atu o tētahi 70% o aua pūtea ki ngā rohe.

I mihia tēnei whakapikinga o te pūtea e mātou, waihoki te whakaaetanga ki te takoha nui o te mahi Kapa Haka i tō tātou whenua o Aotearoa. Mā te whakahokinga mana ki ngā rohe e hora te tūāpapa e piki ai ngā hua papai o ngā Kapa Haka ki ō tātou hapori huhua.

He mea pai tēnei whāngainga pūtea i te wā tika, e pai ai tā mātou tautoko i te huhua o ngā mahi Kapa Haka i roto i ō tātou whānau, i ō tātou hapū, iwi, me ō tātou hapori anō hoki.

I mua atu i te whiwhinga i ngā pūtea, i whakatūria e mātou Te Matatini ki Te Hoe, tētahi rōpū mahi hei kawē whakamua i tā mātou whakaumutanga, hei whakatinana i tā mātou tauira Kapa Haka ā-rohe. Nō te taenga ki te 30 Hune 2023 kua whakaūngia e mātou te tauira whāinga pūtea mō te tohanga o te Pūtea Whakawhanake Rohe, ā, kua whakaaetia tēnei ināianei e te Poari ā-Motu.



Ko tō mātou tūmanako kia ahu whakamua tonu mātou i roto i te tau pūtea hou, i a mātou e tautoko nei i ngā mahi a ō tātou Kapa Haka.

I whakatūria te Rōpū o Te Matatini hei rōpū e mōhiotia nei ko te Rōpū o Te Matatini Kāporeita i te tau 1996, me tōna ingoa motuhake, arā, te Aotearoa Traditional Māori Performing Arts Society Incorporated, ā, ko tāna whāinga nui:

***To foster, develop, and protect Kapa Haka in the pursuit of excellence.***

### Te Ahurei

I tū te New Zealand Polynesian Cultural Festival, tōna ingoa i tērā wā, mai i 1972 ki 1982. E ono ngā ahurei i whakatūria, koia nā te ingoa. Nāwai, nāwai, ā, ka huri te ingoa hei Aotearoa Traditional Māori Performing Arts Festival. Ko taua āhuetanga hōu te ingoa mai i 1983 ki 2003. Tekau ngā ahurei i whakatūria i roto i aua tau. Nō muri mai ka whakaingoatia anō te rōpū (waihoki te Ahurei i ngā tau i muri) hei Te Matatini Society Incorporated i te 2004.

### Te Matatini – The Many Faces

Nā Te Arawa hoki i hautū tētehi kōnohete kore-utu e 2 wiki i muri i te Te Matatini 2023 hei whakaara moni mō ngā takiwā i kurua e te waipuke - Te Tairāwhiti me Ngāti Kahungunu. He hui whai painga tēnei, neke atu i te \$52k i tāpaetia hei aroha ki ēnei rohe.

He wā tino uaua ngā tau o Covid-19 mō te KATOA o ngā rohe o te motu. I whakahīato ngā hinonga me ngā whakahaere o te rohe o Te Arawa i ā rātou rawa, i ākina e rātou ētahi kōkiri, rautaki hoki hei āwhina i te hunga mate āwhina i roto i ngā pōnānātanga me ngā māharahara nui o taua wā. I kawe haeretia he kai, he tautoko ā-rongoā, ā-rawa hoki, i tukua hoki/rānei ki te hunga pāhekeheke nei te noho, arā, ki ō tātou kuia, ki ō tātou kaumatua, kōhungahunga hoki. I whakawhanaketia he mahere whakahaere mōrea Covid-19 kia hāngai ki ngā kaupapa here me ngā ritenga o te kāwanatanga hei āwhina i ngā mōrearea tērā pea ka pā, me te whakaū tonu i te haumarua o tō tātou iwi. E hari ana Te Arawa mō te pai o ana mahi i roto i ēnei āhuatanga kia pūmau ai te hauora me te toiora o te iwi. I piripono anō ngā Kapa Haka ki te tautoko i ēnei mahi, kia haere tonu ai tā rātou whakaurunga ki 'Te Matatini Herenga Waka, Herenga Tāngata'.

I tino manakohia ngā takoha pūtea i tukua mai e koutou ki ngā rohe/Kapa Haka nā ā koutou mahi nui, waihoki ngā aroturukitanga me ngā whakaaro nui mō ia rohe i roto i ngā marama i mua i te ahurei, ā, i te hui anō hoki, nō reira kai ngā raukura o Manumea, te Huia rere hāro tēnei ka mihi ake- mānawatia ngā Amorangi!

E waiata tonutia ana te waiata nei i ēnei rā i te whenua katoa, rite tonu ki ōna waiatatanga tuatahi. E tū tonu ana a Pātea Māori Club ki te waiata, ki te haka, engari kua kore anō e whakataetae. I kīa te rōpū whakataetae ko Aotea Utanganui i ngā tau whakamutunga o te ngahuru tau 1990, ā, e mau tonu nei tēnei ingoa. Ko ētahi atu rōpū i whakataetae i roto i ngā rohe i ngā ngahuru tau 1970, 1980 hoki ko ngā karapu Rangitikei, New Plymouth Māori Club anō hoki, ko Ngāti Tūwharetoa, i haere ki Ōtautahi i te tau 1986 hei kanohi mō Aotea.

I te tau 1990 ka whānau mai te Aotearoa Māori Performing Arts Committee (AMPAC). Ko ngā kanohi kaha o tō mātou rōpū ko Ngaonepu (Sid) Kahu, whai i muri ko Phillip King, me John Nyman. He āwhina tino tēnei tā ēnei tāngata ki te tupunga me te whāinga hua o te Kapa Haka i roto o Aotea, otirā, o Aotearoa. I te tau 1993, ka puta nui, ka tupu hoki te maha o ngā rōpū whakataetae i roto i Aotea, tae atu ki ētahi rōpū pēnei i Te Huatahi (ngā kanohi o Aotea i te tau 1998 me 2000), nā ētahi rangatahi kaingākau ki te reo i tīmata, me te tautoko mai o ngā pakeke pēnei i a Tākuta Huirangi Waikerepuru. 

**Judgements made in the reporting of service performance information**

Te Matatini Society Incorporated National Board, in consultation with the Chief Executive of Te Matatini, has determined what information to present, based on assessment of what was considered most appropriate and meaningful to users when assessing performance against the Te Matatini strategic vision, Annual Plan and Outcome Agreement between Te Matatini and Manatū Taonga – Ministry for Culture and Heritage.

The judgements that had the most significant effect on the non-financial information presented related to the selection of information as to what Te Matatini has achieved in the period, and the selection of performance measures for those key activities particularly where activities are not performed annually.

**Selection judgements**

The selection of key activities to report are based on the four key focus areas identified within Te Matatini Annual Plan 2022/2023. The Annual Plan is based on goals identified under Te Pītau Whakareī, the Te Matatini 10-year Strategic Plan (2017 – 2027). Te Pītau Whakareī aims to foster prosperity through the growth of Māori culture and identity, contribute positively to Māori performance in relation to the wellbeing index and support the economic growth of Kapa Haka communities everywhere. The ultimate aim is for Te Matatini to become an inclusive and integral part of whanau, hapū, iwi and the wider Aotearoa New Zealand society.

**Measurement judgements**

The selection of performance measures for each key activity has been based around both the quantity of funding delivered during the performance year and number of individuals or entities impacted, as this information is retained for both internal management and external funding report purposes.

**1. Statement of Accounting Policies**

**Reporting Entity**

Te Matatini Society Incorporated (the "Society") is registered under the Incorporated Societies Act 1908. These financial statements incorporate Te Matatini Incorporated Society (the controlling entity) and its subsidiary undertaking Aotearoa Kapa Haka Limited - together referred to as the 'Group'.

The Group is involved in the promotion of Kapa Haka for the benefit of Māori and tikanga Māori. The Society's primary objective is to provide these services for the social benefit of people and organisations and not for financial return to equity holders. For this reason it is designated as a Public Benefit Entity (PBE).

**Basis of preparation**

**(a) Statement of compliance**

The consolidated financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). They comply with Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable Financial Reporting Standards, as appropriate for Tier 2 not-for-profit public benefit entities, for which all reduced disclosure regime exemptions have been adopted.

The Group qualifies as a Tier 2 reporting entity as for the two most recent reporting periods it has had between \$2m and \$30m operating expenditure.

These financial statements were authorised for issue by the Executive Committee on 11 October 2023.

**(b) Measurement Base**

The financial statements have been prepared on a historical costs basis.

**(c) Functional and presentation currency**

The financial statements are presented in New Zealand dollars (\$) which is the controlling entity's functional and Group's presentation currency, rounded to the nearest dollar (\$'s).

There has been no change in the functional currency of the Group during the year.

**Use of judgements and estimates**

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised and in any future periods affected.

**(a) Judgements**

Judgements made in applying accounting policies that have had the most significant effects on the amounts recognised in the consolidated financial statements include the classification of revenue as exchange or non-exchange

**(b) Assumptions and estimation uncertainties**

Assumptions and estimation uncertainties applied in the financial statements include the following:

- Key assumptions underlying determining the recoverable amounts for impairment testing
- Useful life, recoverable amount, depreciation/amortisation method and rate
- Residual value of Mahau.

**Significant Accounting Policies**

The following particular accounting policies, which materially affect the measurement of financial performance and financial position, have been applied:

**Basis of consolidation**

**i. Joint ventures**

Joint ventures are those entities over whose activities the Group has joint control, established by a binding agreement and requiring unanimous consent for strategic financial and operating decisions.

Joint ventures that are not structured in a separate vehicle are classified as either jointly-controlled-operations or jointly controlled assets. The consolidated financial statements include the Group's share of assets, liabilities, expenses, and revenues from the jointly-controlled-operation or jointly controlled asset on a line-by-line basis.

**ii. Transactions eliminated on consolidation**

Intra-group balances and transactions, and any unrealised income and expenses arising from intra-group transactions, are eliminated in preparing the consolidated financial statements.

Unrealised gains arising from transactions with equity accounted associates and jointly-controlled-entities are eliminated against the investment to the extent of the Group's interest in the investee.

Unrealised losses are eliminated in the same way as unrealised gains, but only to the extent that there is no evidence of impairment.

**Changes in Accounting Policies**

Changes due to the initial application of a new, revised, and amended PBE Standards

**i. PBE IPSAS 41 Financial Instruments**

PBE IPSAS 41 Financial Instruments is effective from 1 January 2022 and was adopted by the Society on that date.

PBE IPSAS 41 introduces new recognition and measurement requirements for financial assets and restricts the ability to measure financial assets at amortised cost to only those assets that are held within a management model whose objective is to hold financial assets in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. In addition, measurement of financial assets at fair value through other comprehensive revenue and expense is also restricted.

PBE IPSAS 41 has had an immaterial impact on the Society measurement and recognition of financial instruments, as financial assets that were recognised as loans and receivables are now recognised as amortised cost.

**ii. PBE FRS 48 Service Performance Reporting**

PBE FRS 48 Service Performance Reporting is effective for periods from 1 January 2022 and was adopted by the Society on that date.

PBE FRS 48 requires specific disclosures for the reporting of service performance information which have been provided in the statement of service performance.

**Subsidiary and jointly controlled asset**

Aotearoa Kapa Haka Limited is a 100% owned subsidiary (production company) of the Society. The company was incorporated on 7 May 2004.

An agreement with New Zealand Māori Arts & Crafts Incorporated gives Te Matatini joint ownership of the Mahau asset. The agreement also provides for the sharing of costs and revenues on a 50:50 basis.

**Revenue**

The Society derives income through the provision of outputs for the Crown through the Ministry of Culture and Heritage for services to third parties, and income from its investments. Such income is recognised when earned and is reported in the financial period to which it relates.

Revenue is recognised when the amount of revenue can be measured reliably and it is probable that economic benefits will flow to the Group, and measured at the fair value of consideration received or receivable.

The following specific recognition criteria in relation to the Group's revenue streams must also be met before revenue is recognised.

**i. Revenue from exchange services**

**Provision of services**

Revenue from services rendered is recognised in surplus or deficit when the service is rendered.

Amounts received in advance for services to be provided in future periods are recognised as a liability until such time as the service is provided.

**ii. Revenue from non-exchange transactions**

Non-exchange transactions are those where the Group receives an inflow of resources (i.e. cash and other tangible or intangible items) but provides no (or nominal) direct consideration in return.

Grants are recognised as revenue when the conditions associated with the grants have been fulfilled.

With the exception of services-in-kind, inflows of resources from non-exchange transactions are only recognised as assets where both:

- It is probable that the associated future economic benefit or service potential will flow to the entity, and
- Fair value is reliably measurable.

Volunteer services received are not recognised as the fair value of the services are not able to be reliably measured.

Liabilities are recognised in relation to inflows of resources from non-exchange transactions when there is a resulting present obligation as a result of the non-exchange transactions, where both:

- It is probable that an outflow of resources embodying future economic benefit or service potential will be required to settle the obligation, and
- The amount of the obligation can be reliably estimated.

**Employee benefits**

Short-term employee benefits

Short-term employee benefit liabilities are recognised when the Group has a legal or constructive obligation to remunerate employees for services provided within 12 months of reporting date, and is measured on an undiscounted basis and expensed in the period in which employment services are provided.

**Financial instruments**

**(a) Recognition and initial measurement**

Trade receivables are initially recognised when they are originated. All other financial assets and financial liabilities are initially recognised when the Group becomes a party to the contractual provisions of the instrument.

A financial asset or financial liability is initially measured at fair value plus transaction costs that are directly attributable to its acquisition or issue. At initial recognition, an entity may measure short-term receivables and payables at the original invoice amount if the effect of discounting is immaterial.

The Society derecognises a financial asset when the contractual rights to the cash flows from the financial asset expire, or it transfers the rights to receive the contractual cash flows in a transaction in which substantially all of the risks and rewards of ownership of the financial asset are transferred or in which the Group neither transfers nor retains substantially all of the risks and rewards of ownership and it does not retain control of the financial asset.

**(b) Classification and subsequent measurement**

Financial assets

On initial recognition, all of the Groups's financial assets are classified and measured at amortised cost.

A financial asset is measured at amortised cost if it meets both of the following conditions:

- it is held within a management model whose objective is to hold assets to collect contractual cash flows; and
- its contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

These assets are subsequently measured at amortised cost using the effective interest method. The amortised cost is reduced by impairment losses. Interest income, foreign exchange gains and losses and impairment are recognised in surplus or deficit. Any gain or loss on derecognition is recognised in surplus or deficit.

Cash and cash equivalents represent highly liquid investments that are readily convertible into a known amount of cash with an insignificant risk of changes in value, with maturities of 3 months or less. For the purposes of the statement of cash flows, term deposits with maturities of 6 month or less have been included within cash and cash equivalents.

Financial liabilities

All of the Group's financial liabilities are classified and measured at amortised cost.

Financial liabilities are subsequently measured at amortised cost using the effective interest method. Interest expense and foreign exchange gains and losses are recognised in surplus or deficit. Any gain or loss on derecognition is also recognised in surplus or deficit.

**(c) Impairment of financial assets**

The Society recognises loss allowances for expected credit losses (ECLs) on financial assets measured at amortised cost.

The Group measures loss allowances at an amount equal to lifetime ECLs, except for the following, which are measured at 12-month ECLs:

- bank balances for which credit risk (i.e., the risk of default occurring over the expected life of the financial instrument) has not increased significantly since initial recognition.

Loss allowances for trade receivables are always measured at an amount equal to lifetime ECLs. When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECLs, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Society assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when the financial asset is more than 90 days past due. ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all cash shortfalls (i.e., the difference between the cash flows due to the entity in accordance with the contract and the cash flows that the Group expects to receive). ECLs are discounted at the effective interest rate of the financial asset.

**Leases**

**Classification and treatment**

Leases in terms of which the Group assumes substantially all the risks and rewards of ownership are classified as finance leases. The Group currently has no finance leases.

**Operating leases**

Leases that are not finance leases are classified as operating leases.

Operating leases are not recognised in the Group's statement of financial position. Payments made under operating leases are recognised in surplus or deficit on a straight-line basis over the term of the lease. Lease incentives received are recognised as an integral part of the total lease expense, over the term of the lease.

**Statement of Cash Flows**

Operating activities include amounts received from provision of services, investment income and other income sources and payments to employees and suppliers to manage the day-to-day operations of the Group.

Investing activities are those related to the purchase and disposal of investments and property, plant and equipment and intangibles.

Financing activities comprise loans and borrowings.

**Goods and Services Tax (GST)**

All items in the financial statements are exclusive of GST, with the exception of Sundry Receivables and Accounts Payables which are inclusive of GST.

**Income Tax**

The Society is registered as a charity under the Charities Services and as such is exempt from the payment of Income Tax.

The Society has taken legal advice that Aotearoa Kapa Haka Limited will also be regarded as a non taxable charitable entity as it operates solely in furtherance of the Society's objectives.

**Property, Plant and Equipment**

Property, Plant and equipment are recorded at cost less accumulated depreciation.

Depreciation or amortisation is provided on a diminishing value basis on all items at the following rates:

The cost of Mahau is 50% of its construction price to the other joint venturer, being the cost of labour and materials. Mahau is not depreciated as its residual value is considered to exceed its cost.

Purchased software that is integral to the functionality of the related equipment is capitalised as part of that equipment.

**INDEPENDENT AUDITOR'S REPORT

**Opinion**
